## Our " " Plan Includes:

- 1. **Build (or re-build) your website in WordPress.** This will allow you (should you choose) quick and easy access to the content of each page so it can be updated as necessary. I use a custom theme builder called BeaverBuilder. It is the framework for the final product and is used by tens of thousands of developers, so should I kick the bucket or you get tired of me, you can easily find someone else that can step in. WordPress is highly extendable via a system of plugins to add functionality.
- 2. **Add , up to pages.** Content to be discussed and finalized via Zoom, phone and email conversations.
- 3. **Local Page Tagging.** We include underlying "schema" code to tell the search engines who you are, what you do, how to reach you and where you're located in a format that they can understand.
- 4. **Install SEO Tools.** We install plugins that help you get found by the search engines: 1) by creating a sitemap and telling the search engines to come have a look around, 2) by programming the site to use meta content to describe your pages for indexing and display on the search engines, and 3) We also set up Google Webmaster Tools and manually submit your sitemap to both Google and Bing!
- 5. **Set up Analytics code.** We'll create a Google Analytics account and install the relevant code so that we can track how people find your site and what they do when they get there. *You will have full access to the information.* We will also add other analytics code, tracking pixels, etc., if needed.
- 6. **Contact Forms.** We will create up to three forms (your choice) so that potential clients/donors can reach you via your website.
- 7. **Social Media.** We will include links to any social media accounts you may have, as well as include 'sharing' links on the pages of your site (both are optional, but recommended).
- 8. **Hosting.** Web Hosting via .
- Content Creation/Editing. CDG will create or edit pages of SEO-optimized sales content as part of this project.

- 5. Set up contact page/contact forms
- 6. Ensure all layouts are mobile responsive
- 7. Make sure your site is optimized for local recognition by the search engines
- 8. **Post Development:** I'm not going to leave you on your own. Very minor changes and additions will be made without additional charge for the first 30 days, or as long as you have an active plan that includes revisions and additions (not all plans do). If you chose a package that doesn't not include monthly maintenance, after 30 days I am available to help make additions/changes for \$75 per hour.

## **Costs and other specifics**

This project will likely take approximately for development. The timing is based on prompt communication. If you are writing your own content, I can't build the site without it. Likewise, if I ask for clarification, feedback, photo choices, etc., and you do not respond, work stops until I get the information needed to proceed.

The "" website package price starts with a \$ setup fee, including any additional services (half is due before we get started, the other half is due upon completion), then \$ per month, for a minimum of months (or as long as we are maintaining your site).

**Copyrights and Trademarks.** Client represents to CDG and unconditionally guarantees that any elements of text, graphics, photos, designs, trademarks, or other artwork furnished to CDG for inclusion in web pages are owned by the client, or that the client has permission from the rightful owner to use each of these elements, and will hold harmless, protect, and defend CDG and its subcontractors from any claim or suit arising from the use of such elements furnished by the client.

Original art created specifically for client is considered "work for hire" and becomes the property of client (I'm generous that way!); royalty-free (stock) images used in the site content and design remain the property of their original owners and are *licensed for use on this project only*.

**Deadlines.** Client agrees to provide CDG with content for the site within 30 days of the signing of this agreement. Failure to provide content as agreed simply means your website won't have content. It does not relieve you from other contractual obligations included in this agreement. Content received after the 30 day deadline *will be added*, but it will need to be scheduled into our system and may take up to 2 weeks to be processed.

**ADA Compliance.** CDG uses themes and plugins that offer basic ADA compliance. Specialty features, such as animations, slide shows, and non-standard features may not meet all compliance standards.

**Software Licenses.** WordPress is open-source software; there is no charge to use it. The core theme used by CDG is a premium theme for which CDG pays an annual fee; as a secondary user you do not have access to support directly from the theme developer unless you choose to purchase your own license. As long as you have a monthly maintenance plan with CDG, CDG will provide support and renew the licenses. The same holds true for many of the plugins used on the website. The theme and premium plugins either have lifetime licenses or unlimited site licenses and will be renewed by CDG annually until such time that they become obsolete or CDG ceases to use them. If you are paying for maintenance when that happens, CDG will work with you to find an alternate solution.

**Limited Warranty.** You acknowledge that the Services are provided "as is." Neither CDG, nor any of its owner, employees or agents, warrants that the Services will be uninterrupted or error free. CDG is not responsible for and hereby disclaims any warranties, either expressed or implied, regarding the quality, accuracy, or validity of the data and/or completeness, non-infringement, merchantability or fitness for a particular use. **Software.** WordPress is an open-source application that is updated several times a year. Not all updates are required, but most should be implemented for security purposes. Unless the client as an ongoing maintenance contract, updating WordPress and plugins is the responsibility of the client. While we have faith that WordPress will be around for a long time, CDG makes no warranty as to the continued support or operation of this program.

**Browser Compatibility.** Your website will be tested for compatibility in the following browsers (current version at time of project):

- Firefox
- Chrome
- Safari
- · Microsoft Edge

Template designs are tested both on the Windows PC and Mac operating systems as well as iOS and Android mobile devices. We do not code for browsers older than the current release. In addition, we do not code for browsers still in Beta testing.

a small back-link to CDG shall be in the footer of the website.

Additional charges at our hourly fee of \$75/hr., after the final launch, will be incurred for future requests if:

- You add new plugins or features to your site that weren't included in the original project
- A new browser upgrade breaks your theme (e.g. a browser version that didn't exist during the creation of your theme)
- You've made changes or alterations to the code (or you have hired someone other than CDG to do so)
- Your site gets hacked, or otherwise compromised due to something you installed.

**Force Majeure.** A Party shall not be deemed in default of this Agreement, nor shall it hold the other Party responsible for, any cessation, interruption or delay in the performance of its obligations (excluding payment obligations) due to earthquake, flood, fire, storm, natural disaster, act of God, war, terrorism, armed conflict, labor strike, lockout, boycott or other similar events beyond the reasonable control of the Party, provided that the Party relying upon this provision:

- gives prompt written notice thereof, and
- takes all steps reasonably necessary to mitigate the effects of the force majeure event.

If a force majeure event extends for a period in excess of 30 days in the aggregate, either Party may immediately terminate this Agreement upon written notice.

**Rates and Prices.** Prices for maintenance and hourly work are guaranteed not to increase for a period of 18 months. (I've never had to put a disclaimer about prices before; times have changed and prices are rising.)

**Cancellation.** In the event of cancellation of the project, ownership of all copyrights and the original artwork and files shall be returned to/and retained by CDG Marketing & Web Design and a fee for work completed, based on the hourly rate of \$75 per hour, and expenses already incurred, shall be paid by the client.

**Confidentiality.** All correspondence and documents provided will be treated as confidential between the client and CDG Marketing & Web Design, unless all parties involved have granted consent.
